VIII. Old Business (Chairman/Director)

A) Chair for Homeless Veterans Committee

- 1. The position continues unfilled.
- 2. Mr. Dier emphasized that he is personally trying to energize this committee. There are now under 300 homeless veterans in DC and it's important to keep the momentum.
- B) Revising policy on attendance, including proxy voting and telephonic attendance
 - 1. Mr. Ross noted that his outstanding item was to clarify the city's position on whether proxy and telephone voting were permissible. The answers are no and yes, respectively.
 - 2. Mr. Williams shared that he had missed meetings when he was ill, but didn't share that with the board. That is an example of the gap in the bylaws that should be addressed.
 - a. Mr. Ross agreed this needs to be flexible. He's tried putting out a calendar invite, most people don't accept it.
 - b. Mr. Dier shared his perception that most who miss are not missing because they are sick, but have lost interest.
 - c. Mr. Ross noted that the procedure for participating by phonies already on the electronic invitations.
 - 3. Mr. Locks noted that only two board members have given him input on what they would like to put in the new policy.
 - 4. Mr. Khan suggested part of the process might be a meeting with the OVA and board leadership if a member has three absences.
 - 5. One member suggested the board circulate guidance. This would define the board's expectations for everyone what to do if you miss a meeting, etc. This could be like the initial ethics training that all attend, with everyone required to sign and acknowledge.
 - 6. Mr. Dier added that this could take the form of a welcome letter spelling out expectations. He asked to Mr. Dalzell to draft this based on the bylaws and other references.
- C) Headshots and one-paragraph bios from board members for website (MOVA)
 - 1. Still only five members have submitted theirs
 - 2. Mr. Dier suggested a deadline of January, which members seemed to orally agree to.
- D) Proposed D.C.-specific military-to-civilian transition course
 - 1. Mr. Ross gave a presentation last meeting, describing how he wants to start building connections with veterans moving to the city.
 - 2. He is still fleshing out the details and asked board members to send him ideas on what they think should be included, any other details about the course.

IX. New Business (Chairman/Director)

A) Election of Secretary and Parliamentarian

- 1. Per the by-laws, both positions must be elected no later than December 31st for the following calendar year.
- 2. Mr. Dalzell announced that he will not be running for reelection as Secretary but will help transition whoever is elected for 2018. He also noted that agendas and minutes are now being posted on the OVA website, making that part of the position much easier.
- 3. Mr. Locks said he had not year decided if he would be standing for reelection as Parliamentarian.
- B) Strategic Direction- discussion and survey
 - 1. Mr. Dier said he would like to "take the temperature" of the board, how it's being run, its balance between hands-on and advisory roles, and asked the board for their ideas of how to conduct such a survey
 - 2. Ms. Adebayo suggested using Survey Monkey, with a comments section. Others concurred about both points.
 - 3. Mr. Dier added that this is also a chance for all to learn about the board, and asked for ideas on specific questions.
 - 4. More generally, Mr. Spangenberg noted that people have competing priorities, and the leadership wants people to value the experience and feel they are making a difference. He suggested the strategic plan could be updated with the new consensus on what we want to be doing, and energize the committees.
 - 5. Mr. Dier gave his opinion that committee have languished, and the board is doing its work through Ely. He noted that committees are a way to get community members involved.
 - 6. Mr. Locks gave his opinion that the board needs everyone on the same level. Our job is to recommend to the mayor language and laws about veterans. We did at first, but haven't for a long time. We need to review the process where this can work: research-ideas-develop language-send it up. That's one of our main priorities as a board. We're on the hook to give this to the mayor. We need to get back into that mindset. We need to remember why we're here, talk to the community and the ANCs. We need to be in public, get business cards and t-shirts. "That's where we make our sausage." It's important we make our mark by trying to advise the mayor and the city council.
- C) Joel met with Chief of Army Public Affairs, thanks to an ANC 6B commissioner.
 - 1. The office is interested in getting the Army's story out to the public, and the chief might want to come to a board meeting.
 - 2. There may also be contact with the new USCG public affairs officer.

X. Committee Reports (Vice Chairman)

- A) Government affairs.
 - 1. The committee is starting to consider meeting with members of city council.

- 2. Mr. Spangenberg had an idea about Selective Service if the board adopt something now it would be ideal. We could send it again to mayor we had sent one last year, but it stalled in the Mayor's office.
- **3.** Mr. Khan has come up with a new process for when we come up with a new idea. Talk to him if you have an idea on legislation.
